We wish to inform you that pursuant to **Regulation 15(2) of the Chapter IV of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015**, the Listed Entity whose paid up share capital does not exceed Rupees Ten Crore and Net worth not exceeding Rupees Twenty Five Crore respectively, as on the last day of the Previous Financial year is not required to furnish Quarterly Report on Corporate Governance to the Exchange.
