इरोड, 13 अगस्त (भाषा)।

तमिलनाडु के इरोड जिले में सोमवार एक महिला ने तीन महीने के अपने बेटे को कथित रूप से जलाकर मार डाला और आत्मदाह कर खुदकुशी कर ली। पुलिस के अनुसार तूकनैक्केन पलयम गांव में सोमवार सुबह तेनमोझी ने अपने माता-पिता के घर पर अपने और अपने बच्चे के ऊपर मिट्टी का तेल डाल लिया और फिर आग लगा ली। पड़ोस के लोग दौड़े और उन्होंने उन्हें आग की लपटों में घिरा पाया। वे आग बुझाकर दोनों को समीप के अस्पताल में ले गए, जहां डॉक्टरों ने उन्हें मृत घोषित कर दिया। पुलिस के अनुसार महिला के इस कदम की जांच चल रही है।
